The LIHEAP statute (Section 2605(b)(2)(B) or Assurance 2) says that to be eligible a household must have an income that does not exceed the greater of 150 percent of the federal poverty guideline (FPG) or 60 percent of the state median income (SMI) level.(The FPG is the baseline of 100 percent of federal poverty, adjusted each year by the federal government.) In addition, income eligibility levels may not be set below 110 percent of the FPG.

For the purposes of both tabulations, LIHEAP income-eligibility was defined as the greater of 150% of the 2012 Federal Poverty Guidelines published by the U.S. Department of Health and Human Services or 60% of each State's median income, as published by OCS for optional use by LIHEAP grantees in FY 2013 and mandatory use in FY 2014.
